## **President's Report**

President Rao provided a brief report that included the following highlights:

- Commencement is next Saturday, May 12. VCU will be celebrating more than 5,000 new graduates.
- The Institute for Contemporary Art (ICA) enjoyed a successful opening weekend on April 20 -22.
- Several new leaders will be joining us this summer. Beth Angell, formerly at Rutgers, will become the new
  dean of the School of Social Work; Constance Relihan, formerly at Auburn, will become the new dean of
  the University College; and Tomikia LeGrande, formerly at the University of Houston, will become the Vice
  Provost for Strategic Enrollment Management.
- Quest 2025: Together We Transform, the university's next strategic plan, will go before the Board of Visitors next week. Student success is our central mission and will continue to be the principal focus of the new strategic plan. Additional information can be found at <u>quest.vcu.edu/</u>
- The HR Redesign officially went into effect in January and the new plan for A&P faculty will go into effect on July 1.
- The state budget is not yet decided, which leaves uncertainty for VCU. Critically important to the university
  are potential increases to support faculty salaries and student aid, as well as capital construction requests
  in support of STEM labs and emergency repairs to the Trani Life Sciences Building.
- The Governance Task Force, which began its work in October 2017, was charged to develop recommendations to ensure that employees impacted by the HR Redesign are able to fully participate in

shared governance at VCU. Specifically, the HR Redesign creates a new employee group: University & Academic Professionals, for which no existing governance body is designated.

- Lauren Katchuk, president of Staff Senate, and Scott Street, president of Faculty Senate, provided an update of the work of the task force.
  - The Task Force work to date:
    - Researched governance structures at other Tier III institutions in Virginia as well as other peer institutions
    - o Identified alternative models for consideration
    - Evaluated pros/cons of each and forwarded the one they believe to be the best option for VCU to the University community for feedback
  - Comment period ran April 10 to 20, 2018 Now compiling and analyzing that feedback with goal of using the principles above to develop a recommendation to President for a final decision.
  - Next Steps:
    - Representatives from appropriate constituency groups will draft by laws and operating procedures to reflect the new structure
    - o Develop change management and communication plan
    - Hold elections for new Senators
    - New Senators elect officers
    - New structure operational

  - Dr. Secret reported that the Faculty Affairs Committee has completed its <u>Report on the Protocol Review</u> of the Unit Governance Bylaws in accordance with Section 2. School Governance of the University

Council Bylaws that require: (a). The University Council shall ensure that school governance bylaws have been developed and adopted by each school; and (b). The Committee on Faculty Affairs shall regularly review the governance structure of each school in order to ensure that there is representative governance in each school. The findings, which indicated that the three Academic Work Units (schools or colleges) reviewed by the committee were in accordance with the requirements in the University Council bylaws, resulted in the following recommendations and remaining questions:

## Recommendations:

- Process
  - Pair one member of Faculty Affairs Committee with a faculty member of the Academic Work Unit being reviewed to conduct the review; this assures accurate interpretation of the unit governance bylaws, facilitates better/easier modifications of the bylaws in response to review recommendations, and fosters the notion that the review process is a faculty-driven exercise, consistent with the spirit of shared governance.
  - Share the process and template with each unit PRIOR to the review so that each Academic Work Unit has the opportunity to review and modify their document.
- Product: retain the template with the following modifications (see below)
  - Require the Academic Work Unit governance bylaws to include a statement that identifies the committee/group that is responsible for the development and the oversight of the governance bylaws.
  - Require the Academic Work Unit governance bylaws to include a statement that defines the role and responsibility of the Dean and/or Department Chair in developing and implementing the governance document.
  - Modify the template checklist so that each statement in the template is represented in a separate cell

## Questions: (perhaps to be addressed by the Committee that is revising the UC by-laws??)

- We are assuming that the Office of the Provost has the responsibility for ensuring that Academic Work Unit governance by-laws are created and followed at the unit level, but it is unclear how/when this is done. The relationship between the Office of the Provost and the faculty members of a Academic Work Unit as it pertains to shared governance also remains unclear.
- The distinction between 'by-laws' and 'governance document', if any, is not clearly defined. For example, some Academic Work Units refer to their governance bylaws as 'by-laws' and some refer to them as 'governance document', and some refer to them as 'faculty policy handbook'. Do these differences in terminology make a substantive difference for documenting representative governance?
- Clarify which academic units are subject to review of their governance bylaw documents by University Council Faculty Affairs; are these <u>all</u> the units listed under Colleges and Schools on the university website <a href="https://www.vcu.edu/academics/colleges-and-schools/">https://www.vcu.edu/academics/colleges-and-schools/</a> and as Academic Units on the Provost website <a href="https://provost.vcu.edu/academic-affairs/academic-programs/">https://provost.vcu.edu/academic-affairs/academic-programs/</a> (which specifies the Honors College, and the Robertson School of Media and Culture, School of World Studies, Life Science, Office of Research and Innovation, etc) or a subset of these Academic Units?
