1. President's Report

President Rao, provided a brief report that included the following highlights:

Recently traveled to Qatar to welcome Amir Berbic, new dean of VCUarts Qatar.

- Recently updated VCU grads in Boston and Philadelphia on what we are doing to serve students and patients.
- As part of the Make It Real Campaign for VCU, the Invest in Me Initiative was launched this week with a goal to raise \$50 million by June 30, 2022. Funds raised will support scholarships in three areas: talent, opening doors to opportunity, and rewarding excellence. The initiative hopes to lower students' debt load so that they can graduate with less financial stress.
- We recently achieved a historic milestone in research. \$310 million in sponsored research-a record by 13%
- We will only grow-very active last month for research grants: \$50 million form DOD & V.A. to research effects of TBI on service members and veterans; NIH grant to research, end addiction (called NIH HEAL); and Health Resources and Services Administration grant. Our students contribute so much to our research mission—including at the undergraduate level.
- Hume-Lee performed a successful living donor liver transplant over the summer (first transplant of this type at Hume-Lee since 2014)

- 4. New Business Continuity Management Policy (Administrative)—Lori Dachille, Director of Emergency Preparedness, VCU Police Department, discussed the proposed policy and responded to questions.
- 5. Revised Conduct of Animal Research Policy (Administrative)—Susan Robb, Senior Associate Vice President for Research Administration and

Compliance, Office of Research and Innovation, discussed the proposed policy and responded to questions.
